ABOUT US





About

Gruhalaxmi Bahumukhi Mahila Utpadika Samabaya Samiti Ltd. is an all women-led Cooperative based in Dhenkanal district in Odisha. It was formally registered under the Cooperative Societies Act. 1962 on 6th March 2020.

It was formed by incubating and capacitating a community owned and controlled Cooperative that offers livelihoods support to its members. Its objective is to enhance income of the households by enabling women to set up sustainable micro enterprises; reducing the vulnerabilities of poor households and building their financial resilience to deal with risks through establishing access to financial services; enhancing household well-being by creating awareness for improving health and hygiene, safe drinking water and sanitation.

Gruhalaxmi is primarily promoting women-based micro enterprises and has been set up with technical support from ACCESS Development Services and financial support from TATA Steel Foundation under its CSR initiatives. Women in the periphery villages were sensitized on the role that Gruhalaxmi can play in their economic empowerment and enterprise promotion. Women who have an entrepreneurial spirit and those who felt that the Cooperative could change their living standards through livelihood and financial support, enrolled themselves into the Cooperative.

Organisational Structure

Gruhalaxmi is governed by a general body which takes all the important decisions. The Governing Board democratically elects 11 directors which constitute the board of the Cooperative, who take all the important management decisions.



Given the Cooperative's early stage of development, the team leader of the WEE Project has been designated as the Cooperative's secretary by the Board of Directors. In this capacity, the secretary oversees the day-to-day operations of the Cooperative, collaborating closely with the Board for guidance and decision-making. In addition to the Secretary, the Cooperative's livelihood initiatives are overseen by an Enterprise Development Specialist, while the planned microfinance activities fall under the purview of an Inclusive Finance Specialist. The Finance and Accounts department is managed by a Finance Associate. Furthermore, the Cooperative has appointed seven field animators to handle daily field-level activities.

Governance

Gruhalaxmi's governance is overseen by a group of 11 Directors who represent the operational villages. The Cooperative adheres to clearly defined bylaws, which are followed under the guidance of the Governing Board. These Directors are selected through a democratic process by the Governing Body from the operational villages within the Cooperative. In each village, a member is nominated based on specific predetermined criteria.

The Board of Directors of Gruhalaxmi convenes on a regular monthly basis to assess the progress made in terms of livelihood interventions and the Cooperative's collections. During these meetings, feedback is gathered, and plans for the following month are formulated. The Monthly Review & Planning Meeting is chaired by the President of the Cooperative, and comprehensive financial information is presented by the Finance Associate. If necessary, the Board has the flexibility to convene more frequent sessions.

The Board is responsible for making high-level policy decisions, and the Secretary's role is to diligently execute these decisions. All decisions made are meticulously recorded in the Cooperative's Resolution Book.

OUTREACH AND MEMBER INCLUSION

Enterprise promotion is one of the primary focus Gruhalaxmi Cooperative. The cooperative's framework allows it to support, in different capacities, its members in setting up their livelihood enterprises which are viable and revenue generating. The project covered women of 24 villages in the vicinity of TATA Steel factory.

The project targets to enrol 2000 women into the cooperative. By the end of March 2023, 2021 members have been enrolled. The Cooperative has collected Rs.4,04,200 as share capital and Rs. 1,01,050 as administration fee from all enrolled members.

CAPACITY BUILDING TRAININGS

The Cooperative has conducted a series of capacity building trainings for its members over the year. The trainings range from livelihood related trainings (dairy, goat farming, mushroom, detergent making, vegetable cultivation), business development and financial literacy trainings.

The livelihood trainings included demo sessions where the members could see practically how each livelihood activity can be carried out.

LIVELIHOOD PROMOTION ACTIVITIES

One of the main objectives of the project is to encourage members to start their own micro enterprises for which technical support and initial raw material investment will be given through the project. The project has identified a set of enterprises (such as backyard poultry, broiler poultry, grocery shops, fast food shops) based on the local context which it promotes and has also started selling inputs for. In the year 2022-2023, the cooperative was able to promote 289 members to start their own enterprises.

The cooperative has started selling inputs for select enterprises that it promotes which includes backyard and broiler poultry farms, dairy farms and grocery shops. Members of the cooperative who run such enterprises have started purchasing inputs straight from the cooperative. About 112 members currently purchase the inputs for the enterprises from the Cooperative and the list is provided below.

COOPERATIVE'S BUSINESS'

The Cooperative's business comprises of sale of products made by its member enterprises as well as starting small businesses on its own, to build their revenue and profit. As own business, the cooperative manufactured and sold face masks made by its members in the local market in 2020. In 2021, it commenced supplying groceries and vegetables to TATA Steel, and starting from 2022, the cooperative has ventured into selling input supplies for poultry and dairy farm businesses at affordable rates to the community.

Sale of inputs and procuring outputs from dairy and poultry farms is in order to secure the long-term viability of the cooperative by building complete value chains for specific enterprises. In this process, the cooperative can assume the roles of both supplier and buyer for the enterprises. The table below shows the year wise sale and profit earned by the Cooperative.

The cooperative planned for this business as there was a gap in the local Kantabania market, the central market for the villages near the TATA Steel plant, for these inputs. The farmers usually have to travel to distant markets to procure high-quality inputs for dairy and poultry farms, at reasonable prices. By starting this business, the cooperative has not only ensured that farmers have access to quality inputs but has also reduced the transportation costs borne by the farmers. This holistic approach benefits all parties involved and contributes to the overall efficiency and success of the poultry and dairy farming ecosystem supported by the Cooperative. It underscores their dedication to the industry and their capacity to address the diverse needs of entrepreneurs.

Input supply to poultry farmers

As input supply, the cooperative maintains stock of broiler chicks, color birds, feeds and medicine to be bought by poultry farmers when required. In the current year, 21 farmers have bought the inputs from the cooperative, cycle after cycle. The revenue of the cooperative selling poultry inputs has been mentioned in table below.

Input supply to dairy farmers

Business linkage with TATA

The Cooperative had obtained a contract to supply Grocery and vegetables to TATA Jagannath canteens, which are located in its factory and township. The Cooperative's business plan for ensuring regular supply of vegetables and grocery to the canteens is to source vegetables from its members who cultivate vegetables and from other farmers and to procure grocery items from a wholesale supplier and then in turn, supply it to the Jagannath canteens as per their requirements.

OTHER ACTIVITIES

Election For New Board Of Members:

The election of Board of Directors, every two years, is a statutory requirement of a Cooperative. The election for new BoD of Gruhaluxmi Cooperative was held on 19th June 2023. Representatives from different villages nominated themselves for the election. A total of 11 number of nominations were received for the posts available in the BoD.

From the nominated candidates, 11 members were elected through voting and Ms. Padmini Senapati was elected the president of the BoD. These elected members are entrusted with the charge to manage and supervise cooperative's daily business and to make general operational decisions.

Improved Vegetable Cultivation Training

More 100 entrepreneurs in the Cooperative engage in vegetable farming. Apart from cultivation for commercial purposes, most members also grow vegetables for self-consumption. Seeing this as a high involvement activity, several trainings on improved vegetable farming was organised for the villagers, with a special focus on entrepreneurs who wanted to commercially grow vegetables.

The main objective of the training was to help the entrepreneurs to enhance their income from vegetable farming activity. Trainings were held on several topics for improved vegetable farming including understanding soil and its element, how plants grow and its behaviour, crop selection as per soil and main field preparation, treatment for disease control, intercropping practices and plantation, integrated nutrition management, water management and preparation of organic manure.





As Angul and Dhenkanal are high populated industrial towns, there is a great demand for fresh vegetable in the market. The cooperative identified that if the farmers can get properly trained on improved vegetable farming they can make it a profitable farming activity for themselves. Along with training, Improved variety seeds for some vegetables was also provided to the vegetable farming entrepreneurs. They were also trained to select best variety of seed as per the market demand.

SHG Bank Linkage

The Cooperative members and the animators together work towards linking more SHGs with the bank so that affordable, institutional loans can become more accessible to everyone in the community. Through bank linkages, SHGs and members are encouraged to take up individual or group enterprises.

Proper grading of SHGs is a crucial factor for a successful bank linkage to be established, hence the project team and cooperative supports the Anganwadi workers in this task, in order to get the applications.

Through the Cooperative and the Project team's support, 25



SHGs have been linked with a bank in the year 2022-23 and loans worth Rs. 91 lakhs have been availed by these SHGs. The loans have been obtained from Canara bank, SBI, UCO bank, Andhra bank and Union bank of India.

Exposure Visit To Puffed Rice Unit

Six members of Sai Ram puffed rice unit, Sibapur village, which was established with support from the Cooperative, were taken on an exposure visit on 3rd September 2022. The team visited a puffed rice unit established in 2019 under the Dulal Producer Company Ltd. in Mayurbhanj district. This unit has been running successfully for the past three years and has gained substantial market.



The program coordinator of the Dulal Producer Company Ltd. shared the journey of the unit and described their production, stock keeping and sales process. The objective of the exposure visit was for the visiting team to learn about production process, marketing strategy of the unit and share learnings from their growth. The team was also had a hands-on session to prepare the puffed rice under the guidance of the unit members.

Awareness On Government Entitlements And Camps To Facilitate Entitlement Linkage

To increase awareness on government entitlement schemes amongst the community members, a series of awareness camps were conducted in the villages. Schemes such as Pradhan Mantri Surakasha Yojona (PMSY), Pradhan Mantri Jeevan Jyoti Bima Yojona (PMJJBY), Biju Swastha Kalyan Yojona (BSKY), Farmer ID, KYC update of Pradhan Mantri Kisan Saman Nidhi Yojona, Pradhan Mantri Shram Yogi Mandhan Yojona (PMSYMY), registration in Sugam portal for different entitlement of Animal resource development, Horticulture and Agriculture department were covered in these camps.

Convergence With Government Departments

Convergence with government departments can result in synergies that can help improve the scale of project activities. Convergence helps the project and departments to leverage each other's strengths. In the year 2022, the Government of Odisha initiated the process of building a krushak portal for building database of small, marginal, landless cultivators and agricultural labourers in order to improve the outreach for farm related benefits to those entitled. The database includes details such as residential address, landholding, crop details and livestock details of the farmers. The project assisted the agriculture department to build the database in the project areas by conducting village level camps for online registration where the government extension officers were also present to verify the details.

Annual General Meeting

The Gruhalaxmi Cooperative successfully convened its Annual General Body Meeting on December 14, 2022. A total of 250 members actively participated, representing 20 villages from the Odapada and Hindol blocks. The Chief Guest for the event was Ms. Nina Singh, Chief Procurement Officer at Tata Steel Meramandali and Kalingnagar, Jajpur, while the Honorable Guest was Mr. Dibyahas Ray, CSR Head at Tata Steel, Meramandali.



During the AGM, key highlights related to the cooperative's progress were shared. Notably, the cooperative expanded its reach from 12 to 28 villages in Dhenkanal district. Training initiatives covered approximately 1400 members, covering diverse topics such as vegetable farming,

broiler poultry farming, backyard poultry farming, dairy farming, and floriculture. These training programs encouraged women to venture into various enterprises, supporting whom the cooperative's annual income reached INR 51 lakhs and profit reached INR 9 lakhs through the sale of inputs to these enterprises. A significant development in the AGBM involved the proposal and approval of a by-law amendment by the general body members. This amendment allows the cooperative to provide catering services and engage in the sale of milk collected from different dairy farmers, as well as the production and sale of value-added milk products. Additionally, plans for future endeavours were discussed during the meeting. The cooperative aims to establish a grocery shop at the G4 building in the TATA factory and to launch an online service for selling vegetables and fruits. The AGM also included the presentation of the audit report for the year, and the members also approved selection of M/S S. Behera and Associates as the auditors for the upcoming year.

Women's day celebration

International women's day was celebrated by Gruhalaxmi Cooperative on 10th March 2023. 82 members from 12 villages of Odapada and Hindol block had participated. Mr. Dibyahas Ray, CSR Head, Tata Steel, Meramandali was the chief guest for the event.

Ms. Padmini Senapati, the president of the cooperative, addressed the audience with highlights of the significant achievements made by Gruhalaxmi Cooperative through the year. The cooperative not only grew in size to 2011 members but also witnessed introduction of new enterprises for members focusing on the promotion of dairy farming and backyard poultry. The input and technical support provided by the cooperative enhanced their capacities to carry out improved dairy and backyard poultry farming.





The cooperative achieved a remarkable turnover of over INR 30 lakhs through new business activities. Successful entrepreneurs shared their stories on stage, underscoring how they benefited from Gruhalaxmi and transformed into successful women entrepreneurs.

To acknowledge outstanding achievements, various enterprises within the cooperative were honoured with prizes by esteemed guests. The event concluded with a vote of thanks delivered by Ms. Anjali Mohanty, a member of the Board of Directors, expressing gratitude and officially closing the program.

Notes forming part of financial statements

1 Background of Gruhalaxmi Bahumukhi Mahila Utpadika Samabaya Samiti Limited (The Society)

Gruhalaxmi Bahumukhi Mahila Utpadika Samabaya Samiti Limited ("the Society") is registered under the Odisha C-operative Societies Act 1962 at Dhenkanal, vide registration number (01/DKL/06.03.2020).

The primary objectives of the society is to improve economic condition of its members by way of providing opportunities to create micro enterprises and channels to market goods and commodities produced by its members.

2 Significant Accounting Policies:

2.1 Basis of Accounting:

The financial statement of the Society have been prepared in accordance with the generally accepted accounting principle in India (Indian GAAP) under the historical cost convention on an accrual basis.

2.2 Revenue Recognition:

The Society derives revenue principally from sale of product produced by its members. Revenue is recognized when the significant risks and rewards of ownership have been transferred to the buyer, recovery of the consideration is probable.

Other Incomes:

Non-refundable registration fees received from members is recognized as income in the year of receipt. Interest income on deposits is recognized on a time proportion basis.

2.3 Property, Plant and Equipment:

Fixed assets are stated at written down value i.e. cost of acquisition less accumulated depreciation. Cost of acquisition of fixed asset includes all direct expenses relating to acquisition of the asset.

Fixed asset received as donation in kind has been recorded at a nominal value of Rs. 1/- and reflected under "other fund".

Depreciation:

Depreciation is provided on the written down value method in accordance with the rates prescribed under Income Tax Act.

2.4 Inventories

Items of inventories are measured at lower of cost and net realisable value after providing for obsolescence, if any. Cost of inventories comprises of cost of purchase, cost of conversion and other costs including manufacturing overheads incurred in bringing them to their respective present location and condition. Cost is arrived at on FIFO Basis.

2.5 Provisions

Provisions are recognized when the Society has a present obligation (legal or constructive) as a result of a past event which is expected to result in an outflow of resources embodying economic benefits which can be reliably estimated. The amount recognized as a provision is determined based on best estimate required to settle the obligation at the balance sheet date.
